MOSES ANDREW MCCLELLAND 1821-1896

Moses Andrew McClelland was born c1821 in Telfair County, Georgia son of Silas McClelland, Sr. and Penelope Anderson. His parents were married in Bulloch County, Georgia on October 29, 1818. The McClellands were in Tattnall County in 1820 and Irwin County, Georgia in 1830. They moved to Hamilton County, Florida in the late 1830's. In pension applications, Moses claimed military service in Capt. William North's company in Col. Brown's regiment. He stated that he enlisted at Fort Gilmore in 1835 and was honorably discharged at Fort
