White, Georgia. He also claimed service in Capt. William Cone's company

in 1836. No documentation could be provided.

Moses did serve in Capt. North's companies in 1837 thru 1839. He enrolled as "Andrew McLellan" on June 16, 1837 in Capt. North's Company of 2nd Regiment, East Florida Mounted Volunteers. He was mustered in September 26, 1837 at Camp North. Some of his comrades were Rigdon Brown, Isham Crews, Joseph Crews, Sr., Joseph Crews, Jr., Demcy D. Crews, William Crews, Sr., William Crews, Jr., Jesse Hicks, Silas McClelland, John McClelland, James Whidden. He was mustered out with the company on December 18, 1837 at Fort Gilliland. The official records also show that he enlisted as "Andrew M. McClelland" in Capt. North's Company of Florida Mounted Militia again on July 12, 1838 at Camp Gilmer, Middle Florida. He was mustered out with the company on January 12, 1839 at Camp Gilmer.

In the mid-1840's, the McClellands settled in south Florida in Hillsborough County. Moses Andrew McClelland married Sarah Platt at Cork on August 27, 1847. She was the daughter of Peter Platt. Their

children:

- 1. Martha Jane McClelland, born c1850; married on January 7, 1869 Cornelius M. "Dock" Boney, son of David J. W. Boney.
- 2. George W. McClelland, born c1851; married on July 1, 1875 Nancy C. Sellers.
- Moses Andrew McClelland, Jr., born October 27, 1852; died July 22, 1933; married on August 17, 1875 Georgia Ann C. Whidden, daughter of Wade Hampton Whidden. Court he fand
- Dora A. McClelland, born 1854.

5. Ardelia McClelland, born c1856; married Washington Low

In 1850, Moses and family were living in the Itchpsesassa settlement in Hillsborough County near his parents. He served in Capt. F. M. Durrance's Company from December 29, 1855 to August 1856. Serving with him were Jesse, Erastus W., Silas, Sr., William & William E. McClelland, Berrien and Peter Platt.

Moses received Bounty Land Warrant #9205 for 160 acres in the early 1850's. This was based on his service in Capt. North's companies. About 1857 Moses settled in Manatee County. He was a juror at Manatee on April 18, 1859. They were living in the Fort Hartsuff area in 1860.

On October 9, 1863, Moses A. McClelland registered the following marks and brands at the Manatee County courthouse: (1) swallowfork in one ear, under slope & upper bit in the other, brand 21 (2) split & underbit in one ear, under slope & upper bit in the other, brand 21.

Moses and Sarah McClelland were baptized by J. M. Hayman at Bartow

in Polk County on August 7, 1864.

In 1870 they were living in Township 34 - Fort Hartsuff-Zolfo area. On August 31, 1892, Moses, age 71 and a resident of Zolfo, applied for a pension based on his service during the Seminole Indian Wars. Sophia P. Whidden, age 88, resident of Zolfo stated that she had known him for 60 years and Molcy Crews, age 54, resident of Zolfo stated that she had known him for 30 years. Moses received a pension until his death on August 3, 1896.

On August 12, 1896, Sarah McClelland, age 65, applied for a widow's pension. W. M. Crews and T. C. Wadsworth provided information to support her application. Mr. Crews stated that he had lived in the same
